Dear Mrs. Agundez, as you know for your extensive professional career, in the thirteenth session of the Intangible Cultural Heritage of UNESCO, celebrated on Port Louis, Republic of Mauritius, from November 26 to December 1, 2018, Baena and others 16 villages were inscribed on the list of Intangible Cultural Heritage by its drumplaying rituals.

It is the intention of the City Council and the Association of Holy Week Brotherhoods to use the logo that exists for this purpose as a vehicular element that highlights the prestige and cultural value of this ritual and its related elements.

As we know, the use of this emblem must be authorized by UNESCO, through the Ministry of Culture and Sports, as a national authority, so we send you the required form to be able to have this authorization in order to have it to promote the title received a year ago.

We hope to receive an affirmative answer and to be able to use the UNESCO emblem in the activities for promotion of the drum-playing rituals and its tradition.

Attached here are the documents mentioned in this letter, the LR 2018-No. 01208 of UNESCO and the certification of the Junta de Andalucía referred to the inventoried elements.

GENERAL CONDITIONS AND PATRONAGE REQUEST FORM

Scope of Patronage

The use of the emblem of the Convention for the Safeguarding of the Intangible Cultural Heritage in connection with the UNESCO's patronage is governed by the Operational Directives for the Implementation of the Convention for the Safeguarding of the Intangible Cultural Heritage (para 124-150) adopted in June 2010 by the General Assembly of the States Parties to the Convention. They can be consulted on the Internet at http://www.unesco.org/culture/ich/en/directives/.

The emblem of the Convention for the Safeguarding of Intangible Cultural Heritage shall be accompanied by UNESCO's logo and may not be used in isolation. In case of national activities particularly and before sending the completed patronage form to UNESCO, make sure that it is accompanied by official endorsements of your National Commission for UNESCO and National Authority in charge of managing the use of the emblem (in order to find which authority is in charge of this issue, please visit the web pages related to the use of the emblem - http://www.unesco.org/culture/ich/en/emblem/).

Please note that the request should be exclusively addressed to the Director-General and reach UNESCO at least three months prior to the anticipated beginning of the proposed activity.

The completed request form must be accompanied by <u>activity-related layouts and examples of all the printed or audiovisual promotional materials</u> (cinematographic works, books, banners, posters, invitations, etc.) which are expected to bear the emblem of the Convention.

In your request, you should specify the language version(s) for the emblem(s) you require, that is Arabic, Chinese, English, French, Spanish or Russian.

The use of the emblem of the Convention for the Safeguarding of the Intangible Cultural Heritage is only limited to one specific non-permanent activity. The patronage and authorization to use the emblem of the Convention for the Safeguarding of Intangible Cultural Heritage end with the termination of the proposed activity. If the activity takes place again in the future, patronage must be requested anew.

Emblem Specifications

UNESCO decides on the specific type of logo that should apply to each patronage granted. If your request is approved, you will get an electronic file containing a high resolution version of the 2003 Convention emblem, which will enable you to reproduce the emblem on the information material related to the activity. Please note that the emblem of Convention for the Safeguarding of Intangible Cultural Heritage must not be modified or changed in any manner. It must be featured in its minimum size of 12 mm, measured for the height of temple symbol alone. If the emblem is not suitable because of its size, format or any other reasons, you should contact ICHemblem@unesco.org for guidance on how to proceed.

Once your request is approved, you will be asked to complete a <u>Patronage Reporting Form</u> and send it to the Intangible Cultural Heritage Section <u>no later than one month</u> after the end of the activity for which patronage has been granted (six months for publications and audio-visual productions).

The main activity is the Holy Week of Baena itself. Specifically, the Association of Brotherhoods desires the use of the UNESCO logo in the promotional material of this important week in the town. The emblem would be collected in physical support of posters, brochures and the magazine 'Cabildo'. This magazine is presented to the public on the Sunday before Palm Sunday (03.26.2020) in an act of celebration known as the "pregón" of the Easter week.

It would also be included in the website of the Association of Brotherhoods of the Holy Week of Baena, which both this institution and the City Council have redesigned for the achievement of the Internacional Tourist Interest Declaration, adjusting it to current regulations.

It is also the desire of both the City Council and the Association of Brotherhoods, the use of the UNESCO emblem on the Eve of the festivity of San José (St. Joseph), in March, the 18th. It is a tradition in the locality that in the evening night, the drums occupy the streets and sound incessantly until dawn. The logo would be used in the posters to promote this celebration.

The financing and implementation of all promotional activities have a planned budget in the City Council of Baena as well as in the Association of Holy Week Brotherhoods..

The emblem of UNESCO and the 2003 Convention will be used on different media: printed, digital posters, especially in websites and social networks. Its use is also planned in promotional videos that are intended to be broadcast both on television and on web platforms as well as its projection in events related to Holy Week and the drum-playing rituals.

	The objective is to reach a greater promotion at a national and international scope, giving the drum-playing rituals and the Holy Week itself a greater projection.

1	The target audience of the activities will be lovers of drum-playing rituals and its tradition. This will be the whole town of Baena and its region as well as historians, researchers, professors and teachers, young people, drum artisans as well as all those involved in the elaboration of it, suclass carpenters, tanners, etc.		
(The number of participants will depend on the activity to be develope. For example, in Hollweek the number of people of all social strata and of all ages who play the drum in Baens exceeds 3,000. All of them dressed with its specific clothing. On the other hand, in the celebration of the Eve of San José, a tradition in which the drum is the main character, more than 5,000 people participate, in this case without specific clothing.

	The activities related to the drum have a wide media coverage from written press to television. In recent years it has been extended to websites of both general and specialized media.

ľ	The activities to be developed are included within the objectives of the 2003 Convention, for the promotion and dissemination of the intangible cultural heritage, in this case the Drum-playing rituals, an important tradicion in the history of Baena, and a development engine of the city from the artisan and touristic point of view.
